I agree to indemnify and hold harmless Sacramento Camp and Conference Center, their agents and employees from all claims, damages, losses, injuries and expenses arising out of or resulting from my families or my participation in these activities. In short, I cannot sue SCCC and if I do, I cannot collect any money.

I agree that the site of any lawsuit and the law governing any such lawsuit shall be Otero County, New Mexico and governed by New Mexico law. The terms of this agreement shall continue and be in effect after the event at SCCC has ended. As liquidated damages, I hereby agree that if SCCC is forced to defend any action, lawsuit or litigation by myself, my executors, or my heirs, on my family's or my behalf, my heirs or executors and I agree to pay SCCC's costs and attorney fees if they successfully defend such action, lawsuit, or litigation.

Should a court of competent jurisdiction declare any paragraph or part of this agreement unenforceable, the remaining parts or paragraphs shall remain in full force and effect. A copy of this release can be used as if it was an original.

I authorize and release SCCC the use of my (or my minor child's) image in any photograph or video recording for any purpose of SCCC.
